# COP29 participants traveling from outside Azerbaijan will require a visa.



*The Azerbaijan Government has authorized a 'COP29 Special Visa', free of charge, for all UNFCCC-registered participants. It is mandatory to apply for the 'COP29 Special Visa' prior to arrival in Azerbaijan, using the visa application link within the UNFCCC registration confirmation email.*

Visit e-visa portal as soon as you receive UNFCCC registration confirmation email using the weblink.

2

Enter your nationality and type of travel document.

3

Enter UNFCCC registration number, date of birth and passport number.



4

Choose planned travel date to Azerbaijan.

5

Fill in e-visa application form and upload your passport copy (maximum 1MB, .jpg) and complete.

6

Once your e-visa is issued you will receive a link to download it. E-visa allows you to travel for 30 days with a single-entry option.

Participants are strongly encouraged to apply for e-visa as soon as they receive UNFCCC registration confirmation email.

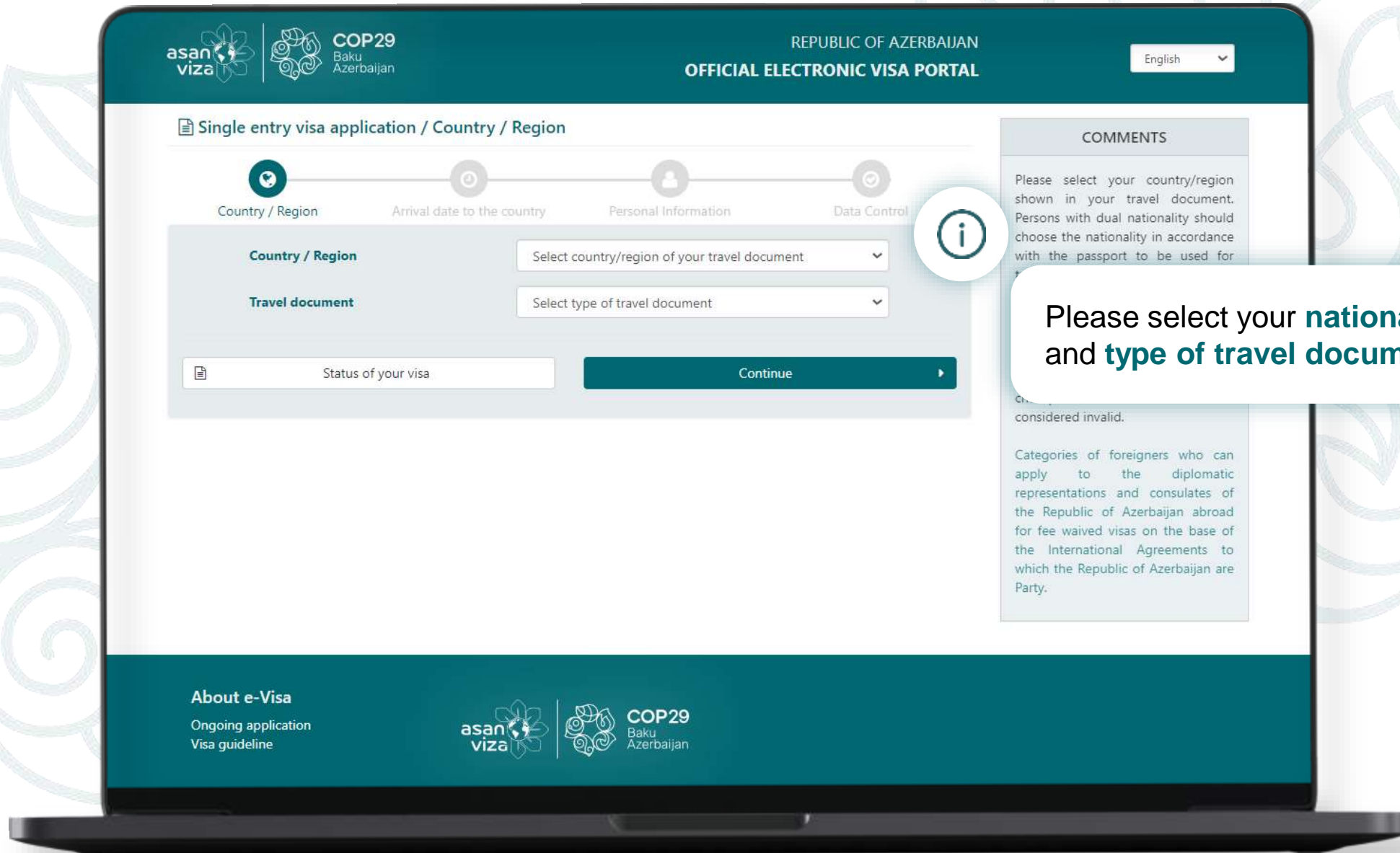

Passport validity should be at least 3 months more than the validity of the e-visa planned to be issued.

Participants must apply for a new e-visa with the same procedure as before if they wish to leave Azerbaijan and return during the COP29. Please note that applicant must apply for e-visa only after leaving Azerbaijan.
